Re: Parental Permission for Students to Visit Bents Green Shops at Lunchtime

Each year, Y11 students are permitted to leave the High Storrs School site at lunchtime to visit the shops at Bents Green. The shops are a short walk (5 mins) from the main pedestrian gate, and students do not have to cross any main roads to get there.

We start to allow students to access Bents Green in the final 3 weeks of Y10, once Y11 have finished their GCSEs and after the completion of Y10 summer trial examinations. Access to Bents Green at the end of Y10 is dependent upon student behaviour during the school day and during the Y10 examinations and attendance and punctuality both to school and to lessons.

Access to Bents Green is a privilege for older students, and we are proud of the behaviour and reputation of our students when they visit Bents Green.

To ensure the safety of students, a member of staff is on duty at lunchtime to monitor students leaving and returning to school, as well as student behaviour at Bents Green.

Although off site, students are expected to follow school rules, and behave in a respectful, sensible and responsible manner at all times, especially when dealing with members of the public. This includes only accessing the shops at Bents Green, remaining on Ringinglow Road and not venturing down the residential side roads such as Bents Green Drive. Access to Bents Green is a privilege and any students who misbehave either at Bents Green or in school may have the privilege withdrawn.

In order to allow your child to leave the school site at lunchtime to visit Bents Green shops, please complete the permission slip below, and return it to student reception by Monday 17th June 2024.

Upon receipt of the permission slip below, students will be issued with their Bents Green pass. Students will need to have their Bents Green pass ready to show the duty member of staff when leaving the site. If students do not have their pass, they will not be permitted to leave the school site. If students lose their Bents Green pass, these will be reprinted by the school but re-issued on a half-termly basis.

In some cases, a small number of Y10 student may not be permitted to go to Bents Green at lunchtime due to their behaviour, regardless of whether parental permission has been granted.

Any student who does not have written parental permission to visit Bents Green will not be permitted offsite at lunchtime,
